# Continia Document Capture

Streamline and automate every step of daily document handling - from receiving and registering a document, to approval, posting and ultimately retrieving previously processed documents from the digital archive.

## **Automated data capture**

PDF files are automatically downloaded from predefined e-mail addresses and processed using award-winning OCR technology - with no user involvement at all.

Paper documents are scanned using a desktop or network scanner and follow the same flow as PDF files.

All relevant information on documents is automatically transferred to the corresponding fields in Microsoft Dynamics, making it fast and efficient to register incoming documents.

## **Invoice processing and management**

Continia Document Capture streamlines processing and managing

purchase invoices with a wide range of new features such as automated vendor detection, documents overview, inbound registration and much more.

Using 3-way matching, invoices can be matched automatically to existing purchase orders or receipts, as well as approved and posted if amounts are within predefined thresholds.

## **Approval workflows for everyone**

Approving invoices can be done either directly in Microsoft Dynamics or online using a web browser - enabling everyone in the organization to access the approval workflow. Approvers can see the original invoice on the screen and either accept, reject, place it on hold, or

forward it to another person for review or approval.

Comments and attachments can easily be added too. With Continia Web Approval Portal, all employees with no direct access to Microsoft Dynamics gain the same opportunities to approve invoices and other documents. No matter where the employee is located, all that is required for accessing and approving documents is internet access.

## **Access documents from anywhere**

The digital archive in Continia Document Capture contains all PDF files and scanned documents, which can easily be accessed from relevant places in Microsoft Dynamics. You can open the original PDF invoice from the posted invoice

card or general ledger entry screen in Microsoft Dynamics.

The digital archive is fully indexed which means you can search for any text on documents, even if the information has not been transferred to a field in Microsoft Dynamics.

This makes it possible to search for a specific reference number, serial number or any other information on purchase invoices and other documents.

Take invoice automation to the next level by processing PEPPOL and XML-based vendor invoices directly in Business Central

## **Automated invoice capturing**

From receiving and registering a document to approval, posting, and ultimately retrieving previously processed documents from the digital archive - all these processes are handled through our market-leading solution, Continia Document Capture.

Just like PDF documents, PEPPOL and other XML documents are automatically downloaded from predefined e-mail addresses or folders. All data is transferred from the imported file into the correct fields in Business Central. Compared to PDF documents, PEPPOL and other XML formats deliver unmatched accuracy and level of details of all the data.

## **Out-of-the-box support of formats**

XML Import allows you to interpret any incoming XML document and

capture this data in Business Central.

Based on the incoming data, the module automatically identifies the type of invoice based on the supported formats. The module comes with a range of popular formats ready to use:

- **PEPPOL BIS 3 (International)**
- **OIOUBL (Denmark)**
- **OIOXML (Denmark)**
- **UBL (International)**
- **EHF (Norway)**
- **SVEFAKTURA (Sweden)**
- **EBINTERFACE (Austria)**
- **XRECHNUNG (Germany)**

If you receive other types of XML files, it is easy to configure additional formats and add these to the catalogue of formats. Extracting additional data out of the document is so easy that a user simply navigates

to the data in the XML document and point it to the right field in Business Central. Either as a change for all vendors or as a change for a specific vendor.

## **Continia Delivery Network (expected by 2020 Q3)**

In 2020, we will introduce Continia Delivery Network integrated directly in XML Import. Continia Delivery Network is a service which integrates into various electronic data exchange networks such as VANs, PEPPOL eDelivery Network and more. This means that if you have vendors already connected to the PEPPOL eDelivery Network you can ask them to send documents this way. Through Continia Delivery Network, these documents will automatically end up directly in your Business Central, ready to process.

More information about Continia Delivery Network will be available in 2020.

## **Built-in document preview and approval workflow**

Because XML Import is built inside Continia Document Capture, the document processes are the same. You get a preview of the invoice directly in your Business Central client, and the document approval is processed in Document Capture the same way as with PDF documents.

## **Add-on solution for Continia Document Capture**

XML Import is included in the software for Continia Document Capture but requires additional licensing. Existing Document Capture customers interested in XML Import need to update their Document Capture to access the solution. XML Import will be available in all versions for Microsoft Dynamics NAV and Business Central that are supported by Document Capture.

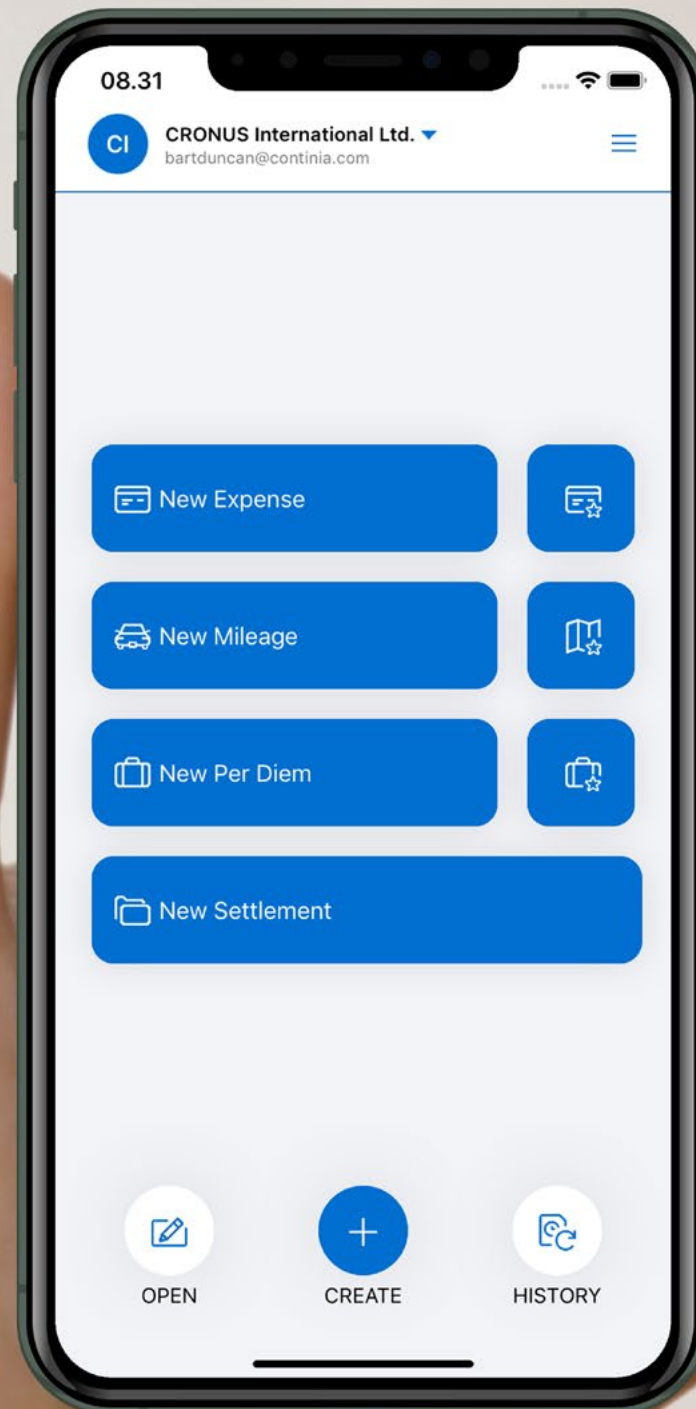

# Continia Web Approval Portal

With Continia Web Approval Portal, every employee can access pending approval documents on the go without using the Microsoft Dynamics client and still gain the same opportunities to approve expenditures and other documents.

## **Approve from a PC, tablet or a Smartphone**

The Continia Web Approval Portal is Web-service integrated directly into the Microsoft Dynamics server. Through this portal, all employees can approve expenditures and documents even though they have no direct access to Microsoft Dynamics. The employee only needs access to a Web-browser.

Regardless of where the employee is situated, the employee can access all expenditures and documents pending approval by using a PC, tablet or a Smartphone on the go through Continia Web Approval Portal.

## **Add any document**

At any time during the approval flow, users can add attachments to the invoice or the expense such as images, spreadsheets or e-mails. The attachments added through the Web Approval Portal are immediately available to other users of Microsoft Dynamics making it fast and easy to look up the attachments – even after the invoice or expense is posted in Microsoft Dynamics.

## **No installation needed**

You can use Continia Web Approval Portal without any additional installation given that the portal runs on our Continia Online Service, which is hosted on Microsoft Azure.

Approvals from the Web Approval Portal happens in real time, meaning that you always have an up to date overview of expenditures and documents pending approval.

## **Two Continia solutions, one web portal**

In one single system, you get access to approve vendor invoices, sales orders, expenses, and mileage. Continia Approval Web Portal only requires one license but can process documents from both Continia Document Capture and Continia Expense Management.

This means that when a user logs on to Continia Web Approval Portal,

documents pending approval from both Continia Document Capture and Continia Expense Management are available.

## **Dynamics NAV license terms**

Please note that when an approval user logs on to Continia Web Approval Portal the approver will, as a minimum, take up a Microsoft Dynamics NAV Limited User. When the user logs out, the Microsoft user license will be released for a new alternative approver.

## **Fully integrated within**

Microsoft Dynamics

Continia Document Output comes with a wide variety of predefined email templates ready to use, each of which is linked to a Microsoft Dynamics report and information about who is to receive them. All you need to do is to customize your e-mail to your own profile, and you are ready to go.

For this reason, Continia Document Output is simpler and cheaper than many other solutions in terms of implementation, development, and maintenance.

## **Pre-built templates**

Continia Document Output comes with more than 20 email templates

ready to use, each of which is linked to a Microsoft Dynamics report and information about, who is to receive them. These templates are designed according to the document type and language. The following ready-made email templates come, among others, as a standard:

- Account Statement
- Delivery Note
- Credit Memo
- Reminder
- Finance Charge Memo
- Sales Invoice
- Quote
- Order Confirmation
- Purchase Order
- Tracking

If you wish to customize your own

templates, this can easily be done as well. Design your templates by using your Outlook client. This way, you can enter in company logos and campaign banners, and attach files and documents if needed.

You can also use merge fields to automatically fill in information such as the sender's name, customer's name, email etc. When you are done setting up your email templates, you need only select the report that you want to use and you are done.

## **Information right at your hand**

With Continia Document Output, you can always see which documents are sent at what time and to whom since all activities are logged.

Unique fact boxes on the Customer Cards provide information about e-mail recipients, access to email log and an overview of the documents. Likewise, fact boxes on Sales Quotes and Sales Orders provide information on email recipients and access to an email log.

With these fact boxes, you have a clear overview of your reports and email activity.

## **Transparent document workflow**

When distributing reports from Continia Document Output, you open up an overview of all unsent documents. This overview indicates who is to receive documents via email, and who requires them in paper form. From here, you can choose whether to process all documents at once or selected documents.

After sending, the documents are marked as sent and will disappear from the overview. You can also configure Microsoft Dynamics to automatically send and print out all of these documents at fixed intervals — once per day, for example, according to your needs.
